

Privacy Policy & Data Protection Statement

Welcome to the unofficial Yooupi Fan Club website (hereinafter referred to as "the Site"). We attach great importance to your personal privacy and data security. This *Privacy Policy* is designed to comply with the requirements of the European Union's General Data Protection Regulation (GDPR) and relevant U.S. data protection laws (such as the CCPA). It transparently explains how we collect, use, store, and protect your personal data, and informs you of how to exercise your rights, including data deletion.

1. What data do we collect?

When you submit the "Membership Registration" or use other interactive features on the Site, we may collect the following information:

- **Information you actively provide:**
 - **Email Address** (Required): Used to contact you.
 - **Name/Nickname** (Optional): Used to address you in emails or future communities.
 - **Your consent preferences:** Such as whether you are an EU resident and whether you agree to transfer your information to Yooupi's official representatives.
- **Automatically collected information:**
 - **IP Address and Access Time:** For the legitimate interests of protecting the website from malicious attacks and spam, the system automatically logs your IP address and timestamp when you submit the form.

2. What is the purpose of data collection?

We collect your data **strictly for the following explicit and limited purposes:**

- **Community Invitations and Notifications:** To send you formal invitations and membership numbers via email when our interactive fan community is ready.
- **Security and Anti-Abuse:** Using IP addresses to limit the frequency of form submissions (e.g., limiting submissions within 24 hours) to maintain the stability and security of our servers.
- **Responding to Official Requests (Consent Required):** **Only if you actively check the consent option in the form**, will we transfer your information to Yooupi or her official authorized representatives if they request fan statistical information from the Site.

3. Data Sharing and Selling (Do Not Sell My Personal Information)

We will absolutely never sell, rent, or trade your personal information to any third-party data brokers, advertisers, or other commercial entities.

We may only share your data under the following circumstances:

- **With your explicit consent:** Such as transferring data to Yooupi's official representatives as mentioned above.
- **Legal Requirements:** If compelled by applicable laws, regulations, or legal processes, we may disclose relevant information.

4. Data Storage and Security

Your data security is critical to us. We use industry-standard cloud service providers (Cloudflare and its D1/KV databases) to encrypt and store your information. We have implemented reasonable technical and organizational measures to prevent data loss, theft, unauthorized access, or disclosure.

5. Your Rights and Data Deletion (Right to be Forgotten)

Under the GDPR and relevant laws, you have full control over your personal data. You may exercise the following rights at any time:

- **Right of Access:** To know what data we hold about you.
- **Right to Rectification:** To request correction of any inaccurate personal information.
- **Right to Withdraw Consent and Deletion (Right to be Forgotten):** You can withdraw your consent at any time and request that we permanently and completely delete all your personal information from our database.

How to request data deletion?

If you wish to view, modify, or permanently delete any personal data you have registered on the Site, please send an email using the **email address you provided during registration** to:

Please include "**Data Deletion Request**" in the subject line of your email. We will thoroughly destroy all your relevant records in our system within a reasonable timeframe (usually no more than 30 days) upon receiving your request and reply to your email to confirm.

6. Minors' Privacy

The Site is primarily intended for an adult audience. We do not knowingly collect personal information from minors under the age of 13 (or 16 in some jurisdictions). If you are a parent or guardian of a minor and believe your child has provided us with personal information, please contact us at the email address above for deletion.
